About the Project

In 2022, the Community Redevelopment Agency (CRA) accepted the final Naples Design District Master Plan. This comprehensive plan is designed to enhance the connectivity and infrastructure of the Naples Design District, focusing on various aspects such as streets, parking, lighting, stormwater management, landscaping, and utilities. Thus, increasing the quality of life and the safety of residents, business owners, and visitors.

Project Limits and Proposed Improvements

Proposed improvements for the following streets include parking, lighting, irrigation, landscaping, bicycle and pedestrian facilities, stormwater, and utility improvements:

- 1st Avenue South Extending from 8th Street South to Goodlette Frank Road
- 10th Street North Extending from Central Avenue to 6th Avenue North
- 12th Street South Extending from 1st Avenue South to Central Avenue

Roadway, irrigation, landscaping, stormwater, and utility improvements are included on:

10th Street North – Extending from 6th Avenue North to 7th Avenue North


Only stormwater and utility improvements are included on:

10th Street South- Extending from U.S. 41 to Central Avenue




1st Avenue South Alternative A1 - Sidewalk Level Separated Bikeways




Includes a raised bikeway which is separated from the roadway. Also included is a sidewalk adjacent to the raised bikeway separated by an amenity zone and parallel parking on both sides of the street.

<u>1st Avenue South Alternative A2 -</u> Shared Use Path




Includes 12-foot wide shared use path and parallel parking on both sides.

<u>10th Street North Alternative B1 -</u> <u>Neighborhood Bikeway / Shared Travel Lanes</u>




Includes sidewalks, striping on the roadway which represents that the travel lane is to be shared between bicyclists and vehicles, and parallel parking on both sides.

10th Street North Alternative B2 -Shared Use Path




Includes sidewalk on west side, shared use path on east side and parallel parking on west side.

12th Street South Alternative C1 - Neighborhood Bikeway / Shared Travel Lanes



Includes sidewalks on both sides, striping on the roadway which represents that the travel lane is to be shared between bicyclists and vehicles, and parallel parking on both sides.

12th Street South Alternative C2 - Shared Use Path



Includes sidewalk on west side, shared use path on east side, and parallel parking on east side.
